Mayor's Letter

Thank you to everyone who participated in the RiverFest & Craft Show on June 1st & 2nd. With the weather cooperating it was one of the most successful shows we have had in the last decade or longer. We especially appreciate those of you who found the time and were able to volunteer for the show. Without your efforts we simply could not have pulled it off. Of course, a special thank you to our Events Director, Julie Little, as well as all the rest of the town staff, who work many hours before, during, and after the show to make it a success. We appreciate each and every one of you.

Town events continue in July, with our popular monthly Trivia Night in River Mill Park taking place on Friday, July 12, and the 257th Army Band playing in the park on Saturday, July 20. Also, if you get a chance, swing by the 100 block of Poplar Alley and check out the new sign at its intersection with Washington Street. On Saturday, June 29, we held a ceremony giving that block the honorary designation "Ogle Harris Way" in honor of Ogle Harris and his family. Ogle Harris founded a grocery at 204 Washington Street in the early part of the 20th century that continued to operate until 1974 under the auspices of his son and daughter-in-law after his passing in 1949. It was a cornerstone of the town's commercial and African-American community. Nearby you may also notice some modest construction taking place at the southeast corner of Washington and Mill Streets. This construction involves the installation of some automobile EV chargers at no cost to the town.

July 1 is the beginning of a new fiscal year for Occoquan. As those of you who follow the town budget process are aware, there have been no changes to any of the town's tax rates. A summary of the budget and tax rates is contained elsewhere in this newsletter, and more information is available on the town web site.

The FY 2025 Budget maintains the Real Estate Tax Rate of \$0.116 per \$100 of assessed value with a due date of December 5th each year. The Meals Tax Rate was maintained at 3.5% and the Transient Tax Rate was maintained at 7%. The Adopted Budget is available online at occoquanva.gov.
